WELCOME AND OPENING REMARKS: Adam Tucker, TMAA President

APPROVAL OF MINUTES: February 22-23, 2024, Nashville, BUSINESS MEETING: The minutes were presented for approval by President Tucker.

FINANCIAL REPORT: The Financial Statement for February 1, 2024 – June 30, 2024 was presented by Nelle Greulich, TMAA Business Manager, in the absence of Danielle Smith, TMAA Secretary-Treasurer. The Financial Statement showed a beginning cash balance as of February 1, 2024 of \$12,756.96; cash receipts of \$19,704.41 for a total cash balance of \$32,461.37, and cash expenditures of \$18,294.36 leaving a cash balance as of June 30, 2024 of \$14,167.01 which balanced with the June 30, 2023 Regions Bank statement. The balance of the Certificate of Deposit was \$10,129.08 for a total cash and investment balance of \$24,296.09.
